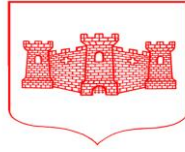

5. ADRODDIADAU'R CYNGHORWYR SIR

Dywedodd y Cynghorydd Bobby Feeley fod cyfarfod i fod i gael ei gynnal cyn diwedd y mis i drafod prosiect y Felodrom, a oedd bellach yn wynebu cynnydd ychwanegol o 13.5 y cant mewn costau adeiladu.

Mae'r drefn o gasglu sbwriel yn newid ym mis Mehefin gyda biniau ailgylchu newydd i gael eu dosbarthu o hyn i fis Mai. Bydd gwastraff ailgylchu yn cael ei gasglu bob wythnos a gwastraff cyffredinol unwaith bob pedair wythnos.

Pennwyd y cynnydd yn y Dreth Gyngor ar 9.3 y cant gyda thoriadau i'r gwasanaeth llyfrgelloedd oddeutu 40 y cant, ac mae disgwyl y bydd toiledau cyhoeddus yn cau. Pan ofynnwyd am brosiectau'r Gronfa Ffyniant Bro, dywedodd fod yr Awdurdod yn cadw rheolaeth ar y gwariant ac roedd o fewn y nod er gwaetha'r toriadau sy'n wynebu'r Cyngor.

Hododd y Clerc y Cynghorydd Feeley am fater a oedd ar ei hadroddiad y mis blaenorol, yn ymwneud â faniau contractwyr sy'n cael eu parcio o amgylch Sgwâr Sant Pedr. Mae'r Cyngor Tref wedi cael cwynion pellach gan drigolion a gofynnwyd i'r Cynghorwyr Sir godi'r mater parhaus hwn gyda'r tîm gorfodaeth.

COUNTY COUNCILLORS' REPORTS

Councillor Bobby Feeley reported there was a meeting due before the end of the month to discuss the Velodrome Project which now faced an additional 13.5% increase in building costs.

The refuse collections are changing in June with new recycling bins being delivered from now until May Recycling collections will be weekly and refuse every four weeks

The Council tax rise has been set at 9.3% with the library cuts of around 40% and the expected closure of public toilets.

When asked about the levelling up projects she stated that that the authority were keeping tight reins on the spending and were on target despite the cuts being experienced by the authority.

The Clerk asked Councillor Feeley about an aspect of her previous month's report regarding parking by contractors' vans around St Peter's Square. The Town Council have received further complaints from residents and asked that County Councillors raise this ongoing matter with the enforcement team.
