192. RUTHIN COUNTY COUNCILLOR REPORTS

Councillor Emrys Wynne reported that Canolfan Awelon would not be closing in 2019. A traffic counting device is to be placed on Mwrog Street to monitor usage and speeds. He reported that the County Council were considering engaging a new environmental enforcement company, who would focus more on dog fouling than dropped cigarette ends. He reported that Denbighshire County Council's council tax increase was 6.3%. Councillor Bobby Feeley provided an update on moving The Clinic from Mount Street to the Ruthin Hospital site, which had secured £1.7 million funding from Welsh Government with the possibility of more. She said that there was now five residents in Awelon and 17 staff. She also said that the County Council is considering an alternative delivery model for Leisure Services, through the proposed creation of an arm's length company.

200. DISABLED CROSSINGS IN RUTHIN

crossing points in Ruthin. The letter referred to problems, especially around St. Peter's Square. Members were keen to put pressure on Denbighshire County Council to undertake the works as soon as possible.

Ltd to discuss the actions required.

201. WELSH CYCLING – PROPOSED NATIONAL ROAD AND TIME TRIALS CHAMPIONSHIP – RUTHIN 2019

Mark Allen, Development Team Leader with Cycling Wales, was welcomed by the Mayor and invited to address the members. He explained that Cycling Wales was keen to hold the National Road and Time Trials Championship in Ruthin on 1 and 2 June. The proposed road race would be held on Sunday, 2 June, starting from Ruthin Rugby Club and going through Llanfair DC, Nant y Garth and Pwllglas, with the finish on the Square at around 12.30pm to 1pm. He estimated that this would attract around 300 spectators and they were also eager to hold mini events in schools prior to the race and hold a children's race on the day. He outlined the road closures required and he was advised by members to contact Denbighshire County Council as soon as possible to discuss this.
