130. WELCOME AND APOLOGIES

The Mayor welcomed everyone to the first Council meeting to be held at the Town Council's Old Courthouse premises. There were no apologies for absence.

131. PRESENTATION FROM CLWYD ALYN HOUSING REGARDING PLANNING APPLICATION FOR 77 AFFORDABLE DWELLINGS AT LAND OFF GLASDIR

The Mayor welcomed Clwyd Alyn representatives Mrs Penelope Storr, Mr Arwyn Evans and Mr Anthony Hughes to give a presentation regarding the planning application for 77 affordable homes. They stated that the site was designated for housing in Denbighshire's Local Development Plan and would have a flexible mix of properties and tenures to meet the need in the local area. In response to comments at the pre-planning consultation, they had checked the capacity of the nearby schools and they had capacity. It was forecast that this development would take 18 to 24 months to complete, if granted planning permission. Members were invited to ask questions and asked how many were on the housing waiting list in Ruthin, what was the meaning of an 'affordable' home and expressed concerns about the access road and traffic and the risk of flooding. The representatives explained that the homes would be affordable to rent or buy based on average income in the area and would be affordable to run also, with running costs around £100 per year. There are 465 on the housing waiting list currently, and they would use a local letting policy to allocate the properties. They had undertaken flood modelling work with Natural Resources Wales to alleviate the flood risk and would introduce a left turn only from the road junction leading from the schools and the proposed new development with Ffordd Glasdir. The Mayor thanked them for their time.
