Have you have had any contact with Gypsies, Travellers or Travelling Showpeople in your area? If yes, please briefly describe what contact.

Travellers set up an unauthorised encampment on the Park Road car park in Ruthin on the August Bank holiday for a period of 4 days from 27-31 August (Friday to Monday). Residents reported this to Town Councillor/s.

On checking this with a County Councillor, informed that DCC had received notification that the group had been removed by the police from Ysgol Frongoch in Denbigh and the group had decided to move on to Ruthin. Understood that DCC had delivered toilets and bins to the site on the understanding that they leave the site on Monday.

The travellers moved from this site in Ruthin at dusk on Monday evening. During the time spent at the site they used the railings as washing lines and left some litter.
