168. MINUTES OF THE PREVIOUS MEETING

The minutes of the previous meeting held on 8 November 2021 were confirmed as correct.

RESOLVED: *that the minutes of the Planning and Development Committee meeting held on 8 November 2021 were confirmed as correct.*

169. MATTERS ARISING

Minute 163: Road Maintenance in Ruthin – Councillor Heather Williams reported that some road signage had been removed as they had been placed in error.

Minute 164: Cunning Green – The Clerk reported that Denbighshire County Council had been contacted and advised of the Town Council's concerns and its request that a full survey and risk assessment was carried out on the Cunning Green boundary wall by the County Council and report issued. An initial response had been received outlining that the wall had been inspected and until it was safe and stable, the Cunning Green route would remain closed to the public. Further detailed information was awaited. Councillor Heather Williams also confirmed that the boundary wall (built in the 1800's) was not included in work which Ruthin Castle Conservation Trust was involved with.

Erection of extension to rear of dwelling and associated works.

172. TECHNICAL ADVICE NOTE (TAN) 15: DEVELOPMENT, FLOODING AND COASTAL EROSION
