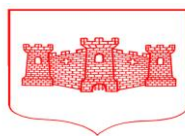

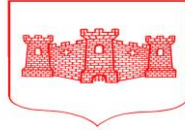

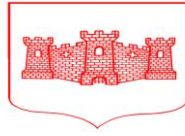
BENCHES – Update regarding the benches to be located on Well Street and Clwyd Street – The clerk confirmed matters were in hand and that the contractor had Received the extended leg
